18. Erin will contact Nick of DYLC to communicate our willingness to work with them to bring ASL enrichment to the camp. As soon as we hear from them, it will be shared with the board.

Treasurer Report: After the last workshop, we now have \$2913.46 in checking and \$2249.02 in savings. We have \$55 in Paypal that we need to transfer. In all, \$5217.48 as of January 10, 2019.

We will invite people involved in local organizations to learn about Sociocracy with the possibility of changing or enhancing their existing organizations. 2. Second Spring workshop: May 4th, 9 am – 1 pm. Topic: Online Teaching (9-11) and then General Meeting and Election after lunch (12-1). The usual pricing for workshop.
3. Garrett moves that we do an open letter video in response to DCS's offer to participate in their fundraising bowl-a-thon stating that we will not participate because we would rather see a Deaf person running DCS, which is a representation of the Deaf community. Adam seconded. Voted unanimous.
